PSA/CPSU Membership Rules

The PSA encourages its members to join its federally registered counterpart, the Community and Public Sector Union (CPSU). The CPSU offers PSA members representation at the federal level at no extra cost.

I understand that:

- (a) the PSA will pay to the CPSU the monies payable in respect of my membership to the CPSU pursuant to the CPSU rules whilst I remain a member of the PSA;
- (b) whenever I am not, or cease to be, a member of the PSA, I agree to pay the CPSU the total of any entrance fees, subscriptions, levies or other fees payable in respect of membership of the CPSU as determined from time to time by Federal Council pursuant to Rule 26 (ii) or Branch Council pursuant to Rule 13 (ii);
- (c) I may resign membership of the CPSU when:
 - (i) I cease to be eligible to become a member of the CPSU or;
 - (ii) by giving notice that not less than 2 weeks after such notice I will have resigned from the CPSU;
- (d) I may resign in the circumstances set out in (c) above by giving notice in writing addressed to the Branch Secretary of the branch from which I am resigning and delivered to that officer;
- (e) I am obliged to pay any dues owing to the CPSU up to the date of effect of my resignation.

(NB: members resigning from the CPSU whose resignation takes effect on the date they also resign from the PSA will not have any dues owing to the CPSU as of that date).
